

**SPEED QUEEN WASHER AND DRYER DOOR PRIZE
SYDNEY AUTUMN HOME SHOW 2021**

TERMS AND CONDITIONS

1. Information on how to enter and the prizes forms part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promotional Period commences on 20 April 2021– 23 May 2021 6.00PM (AEDST).
3. Entry is open to residents of New South Wales only. Employees (and their immediate families) of the Promoter(s) are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
4. Any entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter(s) to enter into a further agreement as evidence of consent to the minor entering this promotion.

 - b. Register their ticket so that it's associated with their contact details. This can be done online or onsite at the event;
 - c. Take their ticket to the Speed Queen stand and have a promotional staff member scan their ticket's QR code;
 - d. Agree to be contacted via the contact details used when registering; and
 - e. Accept the competition Terms and Conditions.
6. The Prize is one (1) premium washer (model number AWNE92 Black) and one (1) premium dryer (mode number ADEE9R Black (Electric) ADGE9R Black (Gas)). Prize pack valued at \$5,000 including GST.
7. If the winner of the prize is under the age of 18 years, the prize will be awarded to the winner's nominated parent or guardian on the winner's behalf.
8. A computerised draw will take place at Speed Queen Office: 245 Rawson St Auburn NSW 2144 before Tuesday the 1st June 2021 at 5pm (AEDST). The first valid entry draw will win the prize indicated in clause six (6) above. The draw conductor may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn.

The Promoter reserves the right, at any time, to verify the validity of entries, registrations and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry or registration that is not in accordance with these Terms and Conditions or who tampers with the entry/registration process. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability for any personal injury or any loss or damage whether direct, indirect, special or consequential arising in any way out of the promotion or use of a Prize.
