

**ECOVANTAGE DOOR PRIZE

TERMS AND CONDITIONS

1. Information on how to enter and the prizes forms part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. **The Promotional Period commences on 27 MAY 10:00AM – 29 MAY 2022 6.00PM (AEST).**
3. Entry is open to residents of Victoria, aged 18+ only. Employees (and their immediate families) of the Promoter(s) are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
4. Any entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter(s) to enter into a further agreement as evidence of consent to the minor entering this promotion.
